註: 1. 本申請表須連同檢附道場推薦函、當地密教總會推薦函、自願書、親人同意書、道場常住或掛單同意函、剃度後服務道場的當地國家合法居留身份證件影印本、無犯罪記錄證明(如無法提供此證明,則需來信詳細說明)、肺結核與B型肝炎檢驗報告,始得受理出家申請。

Note: All application will only be considered with the following submittal of: Recommendation Letters from Local Chapter and Tantric Center of the country of the applicant (if any), Letter of self-voluntary (in taking the ordination), and Letter of Consent (from closest family member). Letter of Agreement between the Temple or Chapters and the applicant, photocopies of the Legal Permanent Residences of the Country of the applicant, no criminal record: Certificate of Good Conduct (If you can not provide this proof, you need to write a letter explaining the reason), Tuberculosis Examination Report, and Hepatitis B Examination Report.

四十五歲以上的申請出家者,資糧(包括健康保險、起居......等等費用)須自備。如出家前一直在道場服務,並經道場理事會同意,則可予開解。

Anyone who is 45 year old or older, applies to be ordained to be a monk/nun, must be self-sufficient financially (including the health insurance, the daily life expenses etc....).

If the applicant has helped the local Temple or Chapter and there is an agreement by the local Temple or Chapter to help the applicant, then there may be an exception to the above self-sufficient financially.
